Global Entry Interview Documents

If you are a UK citizen and applied for Global Entry, and you are not a U.S. lawful permanent resident (green card holder) you must bring an original copy of your ACRO Disclosure Certificate (police certificate) to the interview.

On the day of the interview you need to bring the following global entry interview documents: copy of your "conditional approved" letter; valid passport(s) and one other form of identification such as ID card or driver's license(original); machine readable permanent resident card, if you are a lawful permanent resident(original);

The following original documents are usually required: A valid passport. If you travel using more than one passport, please bring them to the interview so that the information can be added to your file. This provides you with the ability to use either passport at the Global Entry kiosk; A permanent resident card (if applicable);

Scheduling the Global Entry Interview. Once your application is reviewed and conditionally approved, you will received an email stating there is a message in your Trusted Traveler Program (TTP) account. The message instructs you to schedule an interview at one of the Global Entry Enrollment Centers. After logging in, we were able to print off a letter with the conditional approval and schedule an appointment for an interview online.

My interview is next week—in the interview invitation letter it says, "... you must bring with you the following original documents...: This letter; Passport; Documents providing evidence of residency. Examples are a drivers license..., mortgage statement, rental payment statement, ... etc." (emphasis added on documents-plural)

Originally Posted by Global Entry Enrollment Center [Y]ou must bring with you the following original documents to the enrollment center: This Letter inviting you to an interview; A valid passport or permanent resident card.

To complete the interview via EoA, you must be in possession of the following documents: A valid passport. If you travel using more than one passport, please bring them all to the interview so that the information can be added to your file. This provides you with the ability to use multiple passports at the Global Entry kiosk.

Applicants will log into the account and pay the \$100 Global Entry application fee. Once conditionally approval status is granted, applicants will be invited to schedule a Global Entry interview through their TTP account at one of the Global Entry enrollment centers to complete the enrollment process.

My interview was this past Monday, and I am now a member of Global Entry (: I had my interview at DFW International Airport in Dallas. I arrived first thing in the morning, located the office and signed in. There were already 8-12 people waiting for their appointments. After 15 minutes or so, a CBP officer called my name and led me to his cubicle.

What to expect at a Global Entry application interview?

All Global Entry applications must be submitted online through the CBP website, along with a \$100 nonrefundable application fee. After you've received conditional approval, you'll need to schedule and complete an interview. But you may be able to get the Global Entry fee reimbursed (or cover the cost for friends and family members).

Key things to know about getting Global Entry

How to qualify for a walk-in Global Entry interview. First you must apply for Global Entry and receive conditional approval before scheduling an interview. With many U.S. Customs and Border Protection agents assigned to the southern border, many locations are scheduling Global Entry interviews months in advance.

Each applicant will then schedule an interview at a Global Entry Enrollment Center (again, even children must have their own interview) Required Documents : Valid Passport AND 1 other form of government ID (Driver's License, I.D. card, or Permanent Resident Card)

Global Entry Application (GBA) offers paid assistance and consultancy for your Global Entry application. It takes up to 6 months to get to the Global Entry interview stage with us or the government.
